### ADMINISTRATIVE.

Instant investigation was based on allegation that subject was possibly handling Communist propaganda. No information has been developed verifying this allegation, or to indicate that subject is presently pro-FIDEL CASTRO. Miami feels that further investigation is unwarranted and that an interview of the subject would be unproductive, therefore this case is being closed.
