Re Miami letter to Bureau with enclosed summary letterhead memorandum dated 1/15/62 and Buairtel, 6/11/62.

Enclosed for the Bureau are 12 copies of a letterhead memorandum setting forth the summary of rebel activity in Cuba requested in reBuairtel. Twelve copies were designated for the Bureau in order that a copy could be made available to Legats, Madrid, Mexico City and Rio de Janeiro, should the Bureau so desire.

Information copies of this letterhead memorandum have not been designated for offices which received copies of referenced Miami letter and letterhead memorandum as such dissemination does not appear to be necessary.

This memorandum is classified "Confidential" as it contains information from the report of SA MATTHEW D. CRAWFORD dated 4/16/62 at Mexico City, which was so classified.

Enclosed letterhead memorandum does not set forth detailed data regarding individual underground organizations in Cuba as much of the information developed since January,

1962, is repetitious. Furthermore, it is believed that the individual exiled groups in Miami definitely exaggerate the strength and scope of the activities of their counterparts in Cuba. Objective comments from people not directly affiliated with any particular group but active in underground operations substantiates this view.

In addition, recent information indicates that CIA has infiltrated a number of people into Cuba and that these individuals are possibly more active than the unsupported counter-revolutionary groups. ~~(S)~~ (X) (u)
