AT ARLINGTON, TEXAS

The following investigation was conducted by SA JOSEPH L. SCHOTT:

On October 21, 1958, OTTO CRIBBS, Chief of Police, advised that BOB WOODS was known to him as a small-time gambler who was presently running a beer parlor called The Dog Kennel on Highway 157 near Arlington. CRIBBS stated he did not know CASTEN and could not say whether or not WOODS had ever been involved with the subject in gambling or prostitution activities.

On October 2, 1958, BOB WOODS, owner, The Dog Kennel, Highway 157, advised that he did not know CASTEN and had never been involved in any prostitution activities. WOODS stated that he made his living mainly by gambling.

AT FORT WORTH, TEXAS

CRIMINAL ACTIVITIES

The following investigation was conducted by SA JOSEPH L. SCHOTT:

On October 21, 1958, OLIVER BALL, Sergeant, Vice Squad, Fort Worth Police Department, advised that he had talked recently with MARIE THOMPSON, the operator of the Stay Trim Studio on the Jacksboro Highway near Fort Worth, Texas. BALL stated that he had checked this files and could find no record of her ever having been arrested by his department. BALL stated he had questioned her regarding CASTEN's alleged interest in her establishment and she had denied that he was involved in any way with the operations of the Stay Trim Studio.

LEGITIMATE INTERPRISES

The following investigation was conducted by SA ROBERT M. BARRETT:

On November 3, 1958, Dallas T-1, who has furnished reliable information in the past, advised that CASTEN has borrowed \$900 from Dallas T-1 and \$900 from NICK CASCIO in the building of his motel on the Jacksboro Highway.
