N.A. AULL AND MY RETURN CALL TODAY CONCERNING ARTICLE CAPTIONED  
QUOTE TWENTY THREE AMERICANS SIGN UP FOR INVASION OF CUBA UNQUOTE,  
APPEARING IN WASHINGTON POST, DECEMBER TWENTYSIX, UNDER MIAMI  
DATELINE, WHICH MENTIONS THE NAMES TOMMY BAKER, ALVIN WENTZ, WILBUR  
CEE, LARRY BICE, NICHOLAS NERI, AND KEN PROCTOR, AND WHICH DESCRIBES  
ROLANDO MASFERRER AS THERRI LEADER. ROLANDO MASFERRER IS FORMER  
CUBAN SENATOR, PRESENTLY RESIDING IN EXILE IN MIAMI. HE IS ONE

OF MOST PROMINENT ANTI CASTRO FIGURES IN THIS AREA AND IS CONSIDERED  
BY CASTRO GOVERNMENT AS A MAJOR WAR CRIMINAL. MIAMI REPORT OF  
SA JAMES D. HAYES, NOVEMBER SEVENTEENTH, LAST, IN THIS CASE DESCRIBES  
SMALL INVASION FORCE OF MASFERRER SUPPORTERS, WHICH AFTER REN-  
DEZVOUSING IN BAHAMAS, MADE ABORTIVE LANDING ON NORTHEASTERN COAST  
OF CUBA ON OCTOBER THIRD. THIS REPORT ALSO DESCRIBES ACTIVITIES OF,  
AND INCLUDES INTERVIEWS WITH SEVENTEEN MASFERRER SUPPORTERS RECEIVING

YOUNGBLOOD AND JAMES C. GRIZZLE WERE ARRESTED BY MIAMI PD FOR CONSPIRACY TO KIDNAP MASFERRER AND DELIVER HIM TO CUBA. MIAMI SPRINGS POLICEMEN JOHN LOVELL AND FRANK GLIDEWELL WERE ALSO INVOLVED. THIS CASE WAS LATER DISMISSED BY DADE COUNTY COURT FOR LACK OF EVIDENCE. ONE JUNE TWENTY SIX, FIFTY NINE, MM FIVE ZERO ONE DASH C OVERHEARD CONVERSATION AMONG UNIDENTIFIED CUBANS THAT CUBAN WAR CRIMINAL MASFERRER AND OTHERS WERE TO BE KIDNAPPED AND RETURNED TO CUBA. NO FURTHER INFORMATION DEVELOPED RE THIS. ON JULY THIRTIETH, FIFTY NINE, ROBERT PETER ADAMENKO, NYC, ADVISED THAT WHILE IN HAVANA DURING JANUARY, FIFTY NINE, HE WAS OFFERED LARGE SUM OF MONEY TO KILL MASFERRER. ADAMENKO REFUSED OFFER. HE DID NOT KNOW IDENTITIES OF PERSONS WHO APPROACHED HIM. ABOVE INFORMATION WAS SUBMITTED TO BUREAU IN CASE ENTITLED QUOTE CUBAN RETALIATION AGAINST BATISTA ADHERENTS, IS DASH CUBA, BUFILE ONE ZERO FIVE DASH SEVEN FIVE FIVE ONE ONE. MASFERRER AND MIAMI PD HAVE BEEN ALERTED FROM TIME TO TIME OF PLOTS AGAINST HIM. LAST SERIOUS ATTEMPT TO KIDNAP MASFERRER IS PRESENTLY PENDING PROSECUTION IS USDC, MIAMI. THIS CASE IS ENTITLED QUOTE JUAN BUENAVENTURA EUGENIO FERNANDEZ DE CASTRO RODRIGUEZ, ET AL. ROLANDO ARCADIO MASFERRER ROJAS DASH
