At 5:40 p.m. 1-6-61 Assistant AG Yeagley called stating he wanted to bring us up to date on developments in this case following his conversation with the Director yesterday.

Yeagley said that he had talked to Thomas Mann of the State Department last night. Mann talked to Acting Secretary of State Merchant. State's position was that they still thought it would be helpful to their situation if Masferrer's activities were stopped. Therefore, State had no objection to the Department of Justice presenting the matter to a grand jury. Yeagley told Mann that Justice was not anxious to go ahead and would want a request in writing from the State Department that to go ahead would be in the national interest. Yeagley said he had sent a note over to the State Department today along this line but he thinks that State Department is cooling off and he doubts that State Department will send over any request this weekend.

Yeagley said that he had attorneys from the Department of Justice down in Miami but at this point they do not have authority to call a grand jury nor to talk to witnesses. They are not to see the U.S. Attorney and they are not to let their presence be known in Miami except to our office.

We had previous knowledge they attorneys were going to Miami and we have already instructed Miami to furnish these attorneys with any information in this case.

**ACTION:**

For information. Yeagley's call merely brings the situation up to date and requires no action by the Bureau.
