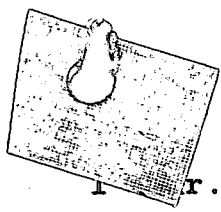

ROLANDO ARCADIO MASFERRER ROJAS, NEUTRALITY MATTER. FOR
INFORMATION OF MIAMI FOLLOWING TELETYPE RECEIVED TODAY FROM
JACKSONVILLE. QUOTE GINES I. RODRIGUEZ. CONFIDENTIAL SOURCE OF
INFORMATION DASH CUBA. NEUTRALITY ACT. RODRIGUEZ ADVISED MARCH
FIRST LAST HE HAS BEEN CONTACTED BY SENATOR MASFERRER REQUESTING
THAT HE CONTRIBUTE SMALL RADIO TRANSMITTER FOR USE BY MASFERRER
DASH S GROUP, POSSIBLY IN CUBA, FOR BROADCAST TO THE CUBAN PEOPLE.
HE STATED THAT HE DESIRES TO ASSIST IN OVERTHROWING THE CASTRO
GOVERNMENT IN ANY WAY THAT IS LEGAL. HOWEVER, HE DOES NOT DESIRE
TO VIOLATE ANY FEDERAL LAWS OR GO AGAINST THE POLICY OF THE U. S.
RODRIGUEZ STATED HE HAD CONFERRED WITH HIS ATTORNEY, MR. CRABTREE,
IN JACKSONVILLE REGARDING THIS MATTER AND THAT CRABTREE HAD TOLD
HIM HE WAS GOING TO CONTACT SENATOR SMATHERS FROM FLORIDA AS TO
WHETHER SUCH A GIFT ON HIS PART WOULD BE WITHIN THE POLICY OF
THIS COUNTRY. RODRIGUEZ SAID HE DESIRED THIS INFORMATION BE HANDLED

WITH SECRECY INASMUCH AS HE HAS RELATIVES IN CUBA. RODRIGUEZ ADVISED THAT HE HAS TO CONTACT MASFERRER TODAY TO GIVE HIS ANSWER AND THAT MASFERRER IS TO SEND TO JACKSONVILLE FOR THE TRANSMITTER TONIGHT. MASFERRER INDICATED THAT THE MATTER WAS URGENT INASMUCH AS THEY EXPECT TO GO INTO CUBA WITHIN THE NEXT FEW DAYS AND THE TRANSMITTER IS DESIRED IMMEDIATELY IN ORDER THAT IT CAN BE TAKEN INTO CUBA WITH QUOTE THEM UNQUOTE. UACB, IT IS CONTEMPLATED THAT RODRIGUEZ WILL BE ADVISED THAT THIS BUREAU CANNOT ADVISE HIM REGARDING THE ACTION HE SHOULD TAKE IN THIS MATTER INASMUCH AS THIS BUREAU IS CHARGED WITH RESPONSIBILITIES INVOLVING THE INTERNAL SECURITY OF THE U.S. AND ENFORCEMENT OF FEDERAL LAWS AND HAS NO JURISDICTION IN REGARD TO INTERNATIONAL MATTERS, AND THAT CONSEQUENTLY ANY ACTION TAKEN BY HIM WILL BE TAKEN UPON HIS OWN RESPONSIBILITY END QUOTE. MIAMI INSTRUCTED CONTACT MASFERRER IMMEDIATELY REGARDING ALLEGATION MASFERRER EXPECTS TO MOVE INTO CUBA NEXT FEW DAYS AND CONDUCT SUCH OTHER INVESTIGATION AS MAY BE NECESSARY TO DETERMINE TRUTH OR FALSITY OF ALLEGATION. ALSO DEFINITELY DETERMINE WHETHER MASFERRER HAS EXPEDITIONARY FORCE OR IS CAPABLE OF LAUNCHING INVASION. SUTEL RESULTS INVESTIGATION. JACKSONVILLE INSTRUCTED SUBMIT EXPLANATIONS WHY ABOVE TELETYPE NOT SUBMITTED MIAMI.
