ReBullets dated 6/23 and 26/59, and report of SA THOMAS H. ERRION, dated 6/18/59, at Miami.

With regard to movement of the OLOKUN II, MASFERRERS yacht, JOHN MOSLEY, United States Coast Guard, Miami, Florida, 6/25/59, advised that his records reflect no movement of the OLOKUN II for any foreign port. He pointed out that regulations provide for the notification of the United States Coast Guard when any vessel, regardless of size, leaves, destined for a foreign port.

On 6/25/59, Inspector ED CUPP, United States Border Patrol, Miami, advised that as of 6/21/59, the OLOKUN II was in the Miami area, and he had no information that it had left for any extended travel out of the Miami area.

MM 639-S advised SA ROBERT JAMES DWYER, 6/25/59, that he had no information re any movement of OLOKUN II.

Page five of referenced Miami report of SA THOMAS H. ERRION, 6/18/59, paragraph 3, line 3, should read 1940 to 1944 instead of 1948. Miami copies have been corrected and appropriate form errors charged.
