

In view of the possible violations referred to in the Department's letter, you should immediately institute an investigation aimed at obtaining legally admissible evidence which would prove the allegations. Obtain signed statements wherever possible. You should submit your recommendations relative to making PSI pnd PSI nobert williams available to the Department as witnesses in this matter. In the event you recommend against such action, you should endeavor to develop other sources who will be able to testify to the same information. You should endeavor to determine the identities of those involved, the source of their funds and the details of their activities. Endeavor to determine if the planes to be utilized in this matter were actually obtained and disguised as indicated.

You should consider an interview with Jaffee concerning the allegation that he flew arms from Miami to Cuba, it being noted that Jaffee has furnished information to your office in the recent past. You should also endeavor to obtain independent verification of the allegation that he made such a flight. Consideration should be given to an interview with

You should also locate and review the bank accounts of Pozo in an effort to determine the source of his funds and whether he receives money from Johnson.
