This is to confirm the conversation between Special Agent James J. Dolan of the Accounting and Fraud Section, General Investigative Division, F.B.I., and G. Allen Carver, Jr. of the Criminal Division on September 15, 1975. That conversation concerned an allegation that Mr. Richard Nunez paid \$100,000 to Mr. Jose Manuel Casanova, head of the Cuban Republican Party in Miami, Florida, for the position of Director of the Cuban Refugee Program. It was further alleged that the \$100,000 was passed on to Mr. Fernando E. C. De Baca, Special Assistant to the President.

In response to Mr. Carver's request, Mr. Dolan agreed to have Messrs. Rolando Masferrer, Steve Clark, Manuel Campos, and Ricardo Nunez interviewed, and to obtain, if possible, Mr. Nunez' signed, sworn statement regarding this allegation.
