Enclosed with referenced New York airtel were numerous photographs of material maintained by FOXTROT and OLGA FIGUEROA in their room in Apartment 52 at 46 Fort Washington Avenue, New York City. This material was made available by NY 4585-S* on August 11, 1964. In the event any information furnished by this source is disseminated outside the Bureau in the future, it should be paraphrased and classified SECRET in order to protect this highly confidential source. (S)

Three of these photographs are of a small address book and are described as follows: (S)

[Photo 257(S)]

On the first line is a number which appears to be 19838113. It is noted that the first digit in this number is faint and there is a possibility that an effort was made to erase it. The significance of this number is unknown. On the third line is the address 1732 West Flagler. According to the 1964 Miami city directory, 1732 West Flagler Street is the address of the Bamboo Bar which has telephone number FR 4-9121. The city directory also reflects that the Bamboo Bar is owned or managed by J. RAMON DE LA TORRE. (S)

The third line contains the numbers 1828. The significance of this number is unknown. (S)

The [name] (S) JESUS BERUVIDES (S) does not appear in the 1964 Miami city directory. According to this directory, telephone [445-6010] (S) is subscribed to by [FELIX BERUVIDES] (S), wife RAMONA, 403 S. W. 30th Avenue. [FELIX BERUVIDES] (S) occupation is listed as [Assistant Manager] (S) of the [New England Oyster House] (S). The directory reflects that [EUGENIO ZALDIVAR] (S) resides at [3360 S. W. 2nd Street, Miami, Fla.] (S)

The [page] (S) of the [notebook] (S) reflected in this photograph contains the name [MASFERRER] (S), Post Office Box 545, Times Square Station, CI 5-7182. It is believed that this refers to [ROLANDO MASFERRER] (S), prominent anti-CASTRO Cuban exile [with whom FOXTROT has associated in the past] (S)

A [new 105-] (S) case is being opened in the Miami Office [on JESUS BERUVIDES] (S) in order to [identify him] (S) further, and attempt to determine why [FOXTROT] (S) has his name in a notebook in his possession.] (S)
