INFORMANT DENIED ANY CP AFFILIATION AND WOULD BE RELEASED LATER IN AFTERNOON FOR DEFERRED INSPECTION. AT ABOUT FIVE FIFTEEN P. M., INFORMANT TELEPHONED SA DAVIS FROM PAY STATION, STATING HE HAD JUST BEEN RELEASED BY INS AND WAS LATE FOR AN APPOINTMENT WITH INDIVIDUAL HE DID NOT IDENTIFY AT THAT TIME. (u)

IN HAVANA AND WAS INSTRUCTED BY AMEIJEIRAS MEET VALDES AT
MIAMI INTERNATIONAL AIRPORT HOTEL ON JAN. TWENTYSEVEN TO
WORK WITH VALDES ON A JOB. INFORMANT INSISTED HE WAS NOT
INFORMED THAT A KIDNAPING PLOT WAS INVOLVED. HE CLAIMED HE
FIRST LEARNED NATURE OF JOB AFTER HE MET VALDES INTERNATIONAL
