On 1/31/75, MM 3240-S who has furnished reliable information in the past, reported on a group he knew only as the Latin American Anti-Communist Group of Puerto Rico, which information he had obtained from MIGUEL "CUCU" de LEON, Bufile 105-155554, Miami file 105-8740, an anti-Castro Cuban activist with contacts in Puerto Rico, following de LEON's return from Puerto Rico in January, 1975.

It has previously been reported that on 10/9/74, MM 1337-S, who has furnished reliable information in the past, advised that a number of bombings had taken place in recent months in Puerto Rico under the leadership of ALDO VERA SERAFIN, a Cuban exile living in Puerto Rico, who periodically visited Miami and conferred with the FLNC leadership in Miami. This source explained that in bombings done in Puerto Rico on the orders of the FLNC in Miami the group has adopted a policy of claiming credit for these bombings by utilizing the names of fictitious organizations such as

the Latin American Anit-Communist Army. They use these fictitious names for the purpose of confusing federal and local police agencies. (See Miami letter with LHM dated 1/7/75 in this case).

Subsequently MM 3240-S obtained additional information regarding this group from de LEON and through contact with several group members. On 2/13/75, MM 3240-S was recontacted specifically to clarify and supplement information previously furnished on 1/31 and 2/11/75 concerning this matter and the following information was obtained:

(u) [Latin American Anti-Communist Group -
Puerto Rico]

The group of young Cuban activists in Puerto Rico who call themselves the Latin American Anti-Communist Group is not known to have any other name or to be affiliated with any other organization. The group in Puerto Rico is under the leadership of an engineer who provides money and leadership, but stays in the background and whose identity is not freely discussed. According to conversation among members of the group, there are members of the FLNC in Puerto Rico who are members of the Latin American Anti-Communist Group. There are apparently some 21 individuals who are considered to be members of this group in Puerto Rico.
