NOTE:

On October 31, 1975, Rolando Masferrer Rojas was killed when a bomb exploded in his car at Miami, Florida. No FBI investigation was instituted inasmuch as the bombing did not fall within our investigative jurisdiction.

In March, 1976, Manuel De Armas, a Cuban exile who was then living in Miami and being utilized as an FBI informant, defected to Cuba. While in Cuba, he made numerous releases to the press at the request of the Cuban Government. In one such interview, which was televised in Havana, he claimed that the explosives used to kill Masferrer were furnished to him by SA Robert Mills of the Miami Office. De Armas claimed that he turned these explosives over to unnamed members of an anti-Castro organization known as Abdala and that members of the organization used the explosives to kill Masferrer. *(u)*
