Re Miami airtel and LHMs dated 7/2/70 pertaining to subject and JULIO ATON CONSTANZO PALAU.

On 7/21/70 copies of referenced LHMs were furnished to the Alto Estado Mayor (Spanish High General Staff - HGS), Madrid, Spain, and to the Direccion General de Seguridad (Directorate General of Security - DGS), Spanish National Police, Madrid, with the request that they conduct the necessary investigation in Spain to verify subject's presence in their country. *(u)*

On 8/31/70 the DGS advised that a check of their criminal and fingerprint records proved negative regarding subject and CONSTANZO PALAU. No information has been uncovered to show that either subject or CONSTANZO PALAU has entered Spain. *(u)*

In addition to the above data, the DGS furnished a copy of an internal report in the Spanish language containing further information, some of which was obtained from Cuban exiles in Spain. It is to be noted that among the data contained in this report, subject may possibly be in El Salvador, Haiti or Santo Domingo, Dominican Republic. In the event any portion of this report is disseminated, it should be classified "CONFIDENTIAL" and the source concealed. *(u)*

Bureau requested to have the report translated and furnish the results of translation to Miami. Miami, *(u)*
