BANKS stated his department had attempted to check out the whereabouts of CASCIO and cit was doubtful that CASCIO was in New York City at the time CARFANO was Tues killed. DL-95-C advised on 9/28/59, that about a week or 10 days prior to the time CARFANO was killed, he had observed NICK CASCIO and RUSSELL DOUGLAS MATHEWS in a conference with each other. Subsequently, both left the Dallas area and were gone about five days. Their whereabouts during that period were unknown. DL-95-C stated he was attempting to obtain more information relative to the whereabouts of these two individuals. An article which appeared in the Fort Worth Press 9/28/59 stated that CASCIO and another Texas hoodlum arrived in New York a short time prior to the murder of CARFANO and left a short time later.
