The area code, 405, referred to by MATTHEWS is undoubtedly MATTHEWS contacts in Oklahoma City, since 405 covers Oklahoma City and MATTHEWS is known to be in frequent contact with GEORGE BARNES, gambler, Wheatland, Oklahoma, located just outside Oklahoma City.
