DETAILS: AT GARLAND, TEXAS

On May 16, 1967, Assistant Chief of Police ED MC CRARY advised that during coverage on Apartment 204 at 200 South Jupiter Road, MATTHEWS was observed to drive up to this apartment in his automobile at 10:50 AM on May 12, 1967. He stated MATTHEWS left in his car the same date at 12:55 PM. On May 15, 1967, MATTHEWS departed from the apartment at 1:00 PM and proceeded to a Mobil Station at the corner of Jupiter and Forest Lane, Garland, but did not use the telephone at this location, as it was under observation. He said MATTHEWS must have spoken to someone at the station and then departed for Dallas and was last seen parking on Ervay Street in downtown Dallas.
