Enclosed herewith for the Bureau are the original and five copies of a letterhead memorandum requesting investigation by the Legal Attache, London, England to determine whether JOSEPH FRANCIS NESLINE, CHARLES TOURINE and DINO VINCENT CELLINI are licensed for employment in any gambling establishment or are registered as owner or part-owner of any gambling establishment in London, England.

Above investigation is based on information received from WF 1103-C, who reported that NESLINE and TOURINE have made trips to London, England in the past to check on gambling operations there in which they have an interest. WF 1103-C reported on 12/28/65 that NESLINE, from England, had telephoned TOURINE at New York City during the latter part of December 1965. On 1/25/66 WF 1103-C advised that he believed that DINO CELLINI was operating the gambling establishment in which NESLINE and TOURINE reportedly have a financial interest.

Copies of this communication are being designated for the Miami and New York Offices for information purposes in connection with their respective cases entitled "DINO VINCENT CELLINI, aka, ITAR, OO: Miami 166-1", and "CHARLES TOURINE, aka, AR, OO: NY 92-851".
