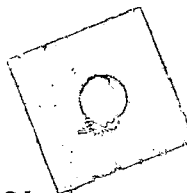

Re Bern letter 4/10/63, entitled "ARMAND DIAZ CERAMI:AR". *u*

This will advise that information furnished by the Bern Office regarding telephone calls made by subject or GEORGE LANGLEY from Lausanne and Clarens, Switzerland, to Monte Carlo, Monaco, Beaulieu and Cannes, France, was furnished to the Police Judiciaire (Criminal Police), Sûreté Nationale (PJSN) and the Monaco Police on 2/28/63 with a request for investigation to determine the identity of the persons called if possible. *X (u)*

The Monaco Police advised by letter of 3/18/63 that telephone number 308080 and 308244 in Monaco are registered to the Hotel de Paris and the Hotel de la Reserve et de Suisse respectively in Monte Carlo. Inquiries made of telephone operators in these two hotels in an attempt to identify the persons receiving these calls resulted negatively. The telephone operators indicated that no records are kept of incoming calls and any notes made at the time the calls are completed are destroyed immediately thereafter. *X (u)*

The Monaco Police also pointed out that the month of August is the height of the tourist season and, therefore, it is impossible to review hotel registers in order to choose names of persons who may have been called by TOURINE or LANGLEY. *X (u)*

The Monaco Police also advised that there is no record of either TOURINE or LANGLEY having visited Monaco during the recent past. They advised that there have been appropriate notations placed in the Monaco police files and we will be advised in the event any pertinent information is received in the future. ~~CONFIDENTIAL~~ (u)

The investigation by the PJSN in France is continuing and the results will be furnished to us as soon as it is completed. (u)

A copy of Miami memo of 4/5/63 captioned "ARMAND DIAZ CERAMI" was furnished to the PJSN on 4/22/63 and they were requested to advise us in the event this individual comes to their attention again in the future. (u)
