Tourine is well-known hoodlum who appeared in London with one Paul Bello. Scotland Yard asked FBI aid in determining purpose of visit and identifying Bello. Several offices have furnished information which was summarized in cables to London on 3/15, 20/62. Subject allegedly representing Florida group in selling gambling equipment to legal gambling clubs in London and has now returned to U.S. (u) *K*
