[redacted] learned from HAZARD, a former chorus girl from the Chez Paree, that she was the favored mistress of subject, who was currently having an affair with PHYLLIS MC KEENE of the MC KEENE sisters, a singing trio.

According to MILLER, subject is in NY staying at the Hampshire House, using an alias other than he normally uses, for purposes of his courtship with MC (MRS. MILLER informed [redacted] the subject was the aliases, FLOID, GIBBONS, HONEY, PEARL, and SOLARIS. He is accompanied by one 'SHEP' (probably JOHN FALCETTA), a Dodgerland (known associate) and is in contact with CHARLES TOURNE, aka., Charles White, and JIMMY DINO.

According to [redacted] MILLER is in daily contact with DINO who is also a friend of subject. MILLER advised [redacted] that DINO has business meetings in his room (1610) at the Savoy Hilton Hotel in NY.

It was determined through DCI BOB COCHRAN that TOURNE is currently staying at the Essex House in NYC.

The report of SA RICHARD J. DUPOY, dated 12/27/57, at Miami, captioned, 'CHARLES TOURNE, was., NY', Miami file 92-106, Bufile 92-2959, reflects, on page 21, a JIMMY DINO as an associate of TOURNE. Miami is requested to obtain and furnish the NYO with background, photo, and description data re DINO.

According to DCI TOURNE, MILLER's address in Chicago is 500 North Rush Street, and she is described as about 23 (possible DOB 6/7/33), 5'4", brown hair, green eyes, very pretty. Subject, who allegedly has about \$100,000 on her during the past year, is aided by MILLER as Chicago's number 2 man, who is to take over when the number 1 man is sent away on income tax violations. MILLER drives a Renault car, serial number 350857 and has an Illinois license (M-430-5523-0762. A voter's stub for MILLER reflects an address c/o C. B. O'ROURKE, 2530 North Magnificent, Los Angeles.

It is noted that on the basis of information furnished by DCI [redacted] NY 98-773-0\* was instituted on 10/26/58, and is in a position to cover activities at JIMMY DINO's current residence in the Savoy Hilton Hotel.

Chicago, Miami, and Los Angeles are requested to determine background data re MILLER in a discreet manner so as not to endanger DCI [redacted].
