In regard to item four, re airtel, on 3/14/64 WF 1108-C, when pressed for additional details re the dice table seized on 6/13/63, advised SA JOHN R. BUCKLEY that on 6/6/63 he moved the table from his residence in the District of Columbia to the rear of the Sportsman's Restaurant, St. Marys County, Md. He explained that the table had been stored in his garage; it was moved at the direction of NESLINE; and no records were kept of the transaction. Informant further advised to his knowledge the only ones aware of his moving the table were NESLINE, TOURINE and ALLEN FISHER, principals in instant case.

It is recalled that WF 1108-C was a part-time employee at NESLINE's Amber Club, Washington, D.C., in 1962 - 1963, the former site of the dice table. Further, it is noted that this informant has been successful in obtaining the confidence of NESLINE and has been a key source of extremely valuable information re activities of NESLINE and TOURINE during the past two years. Because informant occupies this close relationship with NESLINE, WFO feels that
