Informant stated that he knows SANDY NAPLES quite well and that to his knowledge, NAPLES has not been in Canton for approximately ten years. He stated he occasionally speaks to NAPLES on the telephone and invites him to come to Canton, but that NAPLES always claims that he is too busy.

Informant stated he feels certain that NAPLES was not involved in the actual robbery inasmuch as he believed he would have heard of it had he been so involved.

Informant stated that he knows as a fact that GEORGE MIKE FLOREA of Canton knows NAPLES.

Informant stated he has never received any information as to who was responsible for the actual robbery at the National Guard Armory and that he never received any information as to who may have engineered the robbery.
