By separate communication Miami is requesting examination by the FBI Laboratory and Identification Division of several of the envelopes and anonymous letters in an effort to identify the author of these communications.

Miami is of the opinion that the facts contained in this LHM constitute a vicious attempt to discredit MORALES and SA DAVIS because of the successful Federal prosecution of GUTIERREZ, BOSCH and seven other defendants in 1968. BOSCH was paroled from prison on 12/15/72, and is alleged to be a frequent visitor at Replica.

SA DAVIS has warned MORALES to be on his guard since the maneuvers of LESNICK could be designed to establish an alibi of self-defense in the event MORALES is setup for assassination. It is suspected that GUTIERREZ and BOSCH may be responsible for the anonymous letters.

MM 1337-S has expressed the opinion that the Spanish portion of the anonymous letter is characteristic of the style of writing of JORGE GUTIERREZ and contains phrases and expressions frequently used by him.
