On June 4, 1974, ARTHUR CASTRO, Detective, Miami Police Department, and RAUL DIAZ, Dade County Public Safety Department, Miami, advised that they had both been in contact with members of the captioned organization and had determined that the organization is still in existence, but is relatively inactive.

On June 5, 1974, former MM 635-S advised that he has been visiting captioned organization which has now become more of a discussion group rather than an active Cuban exile revolutionary organization.

On June 10, 1974, MAX LESNICK, Editor of Replica, a weekly newspaper published in Miami, Florida, advised that captioned organization is completely inactive, not in touch with the reality of the Cuban exile movement and has no political following in the Cuban exile community.

Inasmuch as captioned organization is not active, has little or no following, and is not considered significant, no further investigation conducted at this time.
