The investigative period of this report overlaps
investigative period of previous report due to the fact that
WFO was not in receipt of the results of investigation of
auxiliary offices at the time the last report was prepared.

Through established liaison, local law enforcement
agencies are being made aware of all pertinent facts contained
in this report.

2/10 Miami is directed to referenced teletype in which MM
1337 advised on 5/6/75 that on the night of 5/5/75 ~~ORLANDO~~
"BEBE" ACOSTA received a telephone call from ~~REINOLY RODRIGUEZ~~
from ~~Puerto Rico~~. RODRIGUEZ spoke "double talk" but the meaning
was clear to ACOSTA. RODRIGUEZ said that "our small brother
will be working tomorrow or the day after." He then said that
this "brother" would be working because the OAS is meeting.
RODRIGUEZ added that ACOSTA would be called again "when the
work is done" so that he could "take care of the rest."

Source said that "our small brother" is a phrase the
FLNC usually uses to refer to "ELAC", the name used by FLNC
when taking credit for a bombing. The phrase "take care of
the rest" means the news release, which would be given out
in Miami.

Miami is also directed to referenced nitel in which SJ 1573-PSI advised on 5/24/75 that it was rumored in the Miami area that the two individuals responsible for the recent bombings during the conference of the Organization of American States at Washington, D. C., during May, 1975, are FELIPE RIVERO and his associate RAMON LNU. Source described RIVERO as being the leader of Los Nacionalistas, a small Cuban exile group in Miami, and RAMON as being the second in charge. RIVERO, who is about 48 years of age, was a prisoner in Cuba after the Bay of Pigs invasion; and is now a salesman for Billmore Motors in Miami. His associate, RAMON, is an extremely dangerous individual and is described as being a white Cuban male in his forties.

WFO source contacted on 6/17/75 with negative results was WF 2037-S, who was out of the country at the time of captioned bombing.

Sources who were contacted in the Newark Metropolitan area who are familiar with matters involving the Cuban community were: NK 5173-S, NK 5775-PSI, NK 6030-PSI, NK 2622-S and NK 2670-S. (S) (X)
