On June 10, 1974, INS Naturalization Examiner
VESSE M. SELLERS, JR., Miami INS Office, advised subject
is currently in the process of petitioning for naturalization
as a U. S. citizen. Mr. SELLERS said that because of a
medical disability, he has recommended that petition be denied,
but because subject's wife is a U. S. citizen, he will be
allowed to reapply under a different section of the
naturalization laws.
