C. LEGITIMATE ENTERPRISES

Proposed Sale of Property Located in Pittsburgh, Pa.

On June 15, 1961, PG T-1 advised that LA ROCCA has property for sale in Pittsburgh and is asking 350, not otherwise explained, for this property. He explained that an interested buyer is ANTHONY MOLINARO, who owns the Pittsburgh Parking Lot at Tunnel and Chatham Streets, Pittsburgh, which is adjacent to the Washington Trust Office of the Western Pennsylvania National Bank where LA ROCCA has a real estate account. According to this informant, LA ROCCA was giving this matter his personal attention.

On June 12, 1961, PG T-1 indicated that supervisory employees of the North Star Cement Block Company indicated that they were worried about an investigation to be conducted by the Internal Revenue Service at Pittsburgh and that ALDO PRUNER, manager of the block plant operation, suggested that all supervisory employees must come up with likely stories and must necessarily have the same answers. This information was disseminated to the Intelligence Unit of the Internal Revenue Service at Pittsburgh on a confidential basis on July 24, 1961.
