Re Report of SA ROBERT A. VOEGE, 12/23/58, at Pittsburgh.

On 12/24/58, SA PAUL A. TURNER contacted the office of MR. MAX GOLDBERG, in Baltimore, and was advised by an unidentified male employee of MR. MAX GOLDBERG, that GOLDBERG died in a hospital in Pittsburgh within the past two weeks. This individual stated that members of MR. GOLDBERG's staff of accountants were aware of the interest of the FBI in locating the subject LA ROCCA, and they would contact this office if they have any subsequent dealings with the subject.

On 12/31/58, MRS. MAX GOLDBERG, advised SA TURNER that her husband died at Pittsburgh, Pa., on 12/10/58, and was buried there. She stated that she has not observed the subject and has received no information concerning his whereabouts since the death of her husband. She advised that if any information comes to her attention in the future concerning the subject, she will furnish it to the Baltimore Division. She indicated that she intends to continue her husband's accounting operations since she was active in this organization for many years. She noted that the Baltimore Staff of her husband's business did not know A ROCCA. When asked if any members of the Pittsburgh Staff would know LA ROCCA, MRS. GOLDBERG was evasive in answering.

No further efforts will be made to contact MRS. GOLDBERG in the absences of a specific request from the Pittsburgh Office. - RUC -
