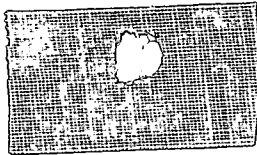

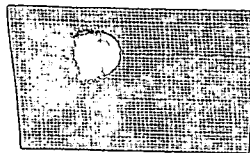

ReBuairtel to New York, captioned, "CRIMINAL INTELLIGENCE PROGRAM," dated 2/15/61.

PG 585-C has advised that FRANCES PRIAM, former paramour of LA ROCCA, is now doing a fairly good business as a medium-priced prostitute in the Baum Blvd., area of Pittsburgh, where she is operating with a girlfriend who has not been exposed to the rackets. This informant advised that the Phoenix Motel at Monroeville, Pa., which is operated by MIKE GENOVESE, Pittsburgh, and National Top Hoodlum, who is the protege of LA ROCCA, has become virtually flooded with prostitutes who are working on independent basis with the approval of GENOVESE who ostensibly has the approval of LA ROCCA. In this regard, Thursday nights appear to be extremely active because a free-food spread, buffet style, is laid out by the motel management for all of the drinking customers. Local racket men seeking action prefer this night of the week and most have light dinners so that they can gorge themselves with Italian delicacies from about 10:30 P.M., to 2:00 A.M.

IN VIEW OF THE CONVICTION OF LA ROCCA FOR ASSAULT WITH INTENT TO KILL AND HIS ARREST FOR CARRYING A CONCEALED WEAPON, HE MAY BE ARMED AND SHOULD BE CONSIDERED DANGEROUS.
