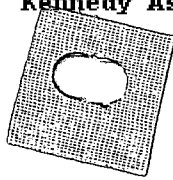

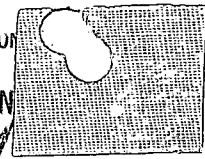

SEBASTIAN JOHN LA ROCCA, AKA., AR. DAILY TELETYPE SUMMARY.

TOP ECHELON INFORMANT CLOSE TO LA ROCCA ADVISES BIG DIFFERENCE IN ORGANIZATION OF FORMER YEARS AND ORGANIZATION OR SYNDICATE TODAY IS THAT LOCALITIES ARE SPLIT OR DIVIDED INSTEAD OF HAVING ONE MAN IN CONTROL OF A LARGE AREA. HE SEES PITTSBURGH AS DIVIDED AMONG MANNARINO BROTHERS, LA ROCCA AND MIKE GENOVESE PRIMARILY AND STATES THAT EITHER LA ROCCA OR SAM MANNARINO IS THE INDIVIDUAL MAKING THE BIG DECISIONS IN HIS ORINION. HE STATES AGE AND LENGTH OF MEMBERSHIP IN SYNDICATE ARE CONTROLLING FACTORS AND CITED TWO INSTANCES WHERE LA ROCCA HAD INTERVENED SUCCESFULLY FOR HIM AGAINST GABRIEL MANNARINO.
