Comandos L, apparently knowing that RALPH HERNANDEZ is in contact with Mr. KOUN's Office, may have intentionally planted this allegation with HERNANDEZ, through HEMMING, for the purpose of uncovering any informers within Comandos L. It has been noted that Comandos L leaders are extremely upset over the recent seizures of their boats and guns by the Customs Agency Service.

In view of the possibility, as set forth in No. 2 above, this office, UACB, will conduct no active investigation to determine [if Comandos L has made any recordings of conversations involving personnel of this office] as it is felt that such inquiries, if conducted through logical informants, such as [MM 639-S] would jeopardize the security of such informants. [It is to be noted Mr. KOUN's memo reflects that his source, HERNANDEZ, was unable to learn when and how the alleged recordings of conversations involving FBI personnel took place; however, this memo reflects the tape recordings of conversations involving Mr. KOUN's field office, and conversations between personnel of the FBI and the Customs Agency Service, allegedly took place during a period of two or three weeks, approximately four months ago] The regular security precautions taken by this office to uncover possible telephone line taps have failed to reveal any telephone taps.
