On 12-7-63, U.S. Coast Guard advised they stationed a 40 foot USCG boat at the mouth of the Miami River and alerted their aircraft and patrol boats in the Florida Keys. *(u)*

On 12-6-63, INS, Miami, advised they are aware of the third agency reports (CIA reports) and the U. S. Border Patrol is on the alert. *(u)*

On 12-7-63, U. S. Border Patrol advised that agency is closely following this matter, is on the alert, and will notify FBI of any developments.
