Customs, Miami, advised CUESTA is cooperating with Customs in connection with plans of ROLANDO MASFERRER to stage operation against Haiti but has no intention of actually cooperating with MASFERRER in this matter.

It is noted Customs was also in contact with CUESTA prior to the 11/14/65 raid which caught Customs by surprise. Apparently, CUESTA did not notify Customs on other agency in advance re that raid.
