The above (code name has been assigned to) a Cuban (S) alien whose activities are being (directed against) the Cuban (S) Intelligence Service (CIS). This Cuban alien was requested by (CIS) to obtain information concerning the activities and (S) operations of an anti-Castro organization in Miami, Florida, known as COMANDOS L. (S)

Through various contacts and activities, the following information was obtained (S) (u)

There was a meeting on August 14, 1967, at 9:00 a.m. at the Miami Colonial Hotel for the purpose of reporting on a measure which was being taken to obtain the release of ZALDIVAR and CUESTA. The following were present: EDGARDO DIAZ, MARIA GOMEZ CARBONELL, MANOLO CASTANEDO, RAUL GRAMATGES, MARTINIANO ORTA and ALFREDO GOMEZ. The last is a leader of the Committee of the 100, an organization which is trying to obtain the release of 100 Cuban political prisoners. Steps are being taken by this Committee in Bolivia by JORGE ROBLEJO to try to exchange REGIS DEBRAY for 100 or more Cuban prisoners. It has turned out that when the Bolivian authorities saw the list of the possible Cuban prisoners who would be included, they wanted ZALDIVAR and CUESTA to be put on the list. This was what Mr. GOMEZ wanted to report to COMANDOS L, in order to see if they knew that this was being done and if they wanted this effort to be continued. Apparently a telegram sent by CUESTA's daughter to a Bolivian Senator had resulted in this Senator requesting that CUESTA and ZALDIVAR be included on the list of prisoners who would be exchanged for REGIS DEBRAY (u)

Through various contacts and activities, the following information was obtained: (S) (u)

On Friday, August 11, 1967, the leaders of Comandos L met at 9:00 p.m. at the Miami Colonial Hotel for their monthly meeting. The following were present: ALFONSO RUIZ, Dr. MARIA GOMEZ CARBONELL, MANUEL CASTANEDO, EDGARDO DIAZ, EDUARDO BAEZ (military chief), RAMON FONT (former military chief), Mrs. CARIDAD TRUJILLO, Mrs. BLANCA DE ABRIL, Mrs. BLANCA VILLA, ANGEL PARDO JIMENEZ, and some other delegates. The main subject was whether or not a representative from the organization should be sent to the meeting which was going to be held at the YMCA the following day, under the sponsorship of AGRUPAMIENTO CIVICO, which is headed by JORGE MAS, JOSE IGNACIO RIVERO, ERNESTO FREYRE, CARLOS MARQUEZ STERLING and others. The purpose of this movement is to unite the Cubans in exile in order to wage war on Cuba. At the meeting, it was agreed that COMANDOS L would be represented by DIAZ and RUIZ (if he could attend, since he had a previous engagement) and by ANGEL PARDO JIMENEZ. They would attend as observers only, since this was another attempt to unite the Cubans, but there was little hope that it will be effective. (S) (u)

It is (requested that clearance be granted] for the (S) Cuban alien to furnish this data to (CIS). (S)
