By teletype 3/28/63 Miami Office has advised that on 3/27/63 Coast Guard representative at Miami advised that on 3/24/63 Coast Guard observed the yacht "Alisan" at unnamed island located between Anguila Key and Damask Key in the Cay-Sal group in the Bahamas, about 70 miles from Caibarien, Cuba. Eight men, some Cuban in appearance, were observed on board and "Alisan" had in tow a small tender and what appeared to be speed boat, about 20 feet in length.

In connection with this information, Miami interviewed Lucia Fernandez, wife of Santiago Juan Antonio Alvarez Rodriguez, who owns the "Alisan." She advised her husband left on the "Alisan" about 15 days ago for Anguila Key and that he was expected to return this week. She denied that her husband has any connection with the anti-Castro group, L-66.

A source, who has furnished reliable information in the past, has advised that the "Alisan" has been engaged on numerous occasions in the past in military-type expeditions against the north coast of Cuba operating from the Cay-Sal Bank in the Bahamas. *(u)*
