COMMANDOS L 66. RA - CUBA. NM. NEUTRALITY MATTER.

-TODAY SANTIAGO JUAN ANTONIO ALVAREZ RODRIGUEZ

ADVISED HE WAS FORMERLY MEXICAN DOCTOR AND SENATOR IN
CUBA, PRESENTLY RESIDES MIAMI, IS UNEMPLOYED, OWNS AND
OPERATES THE ALISAN, CUBAN CRUISER HAVING TWO DIESEL ENGINES.

HE SAID ALISAN LEFT MIAMI MARCH 17 LAST AND WENT TO
VICINITY OF ORANGE KEY ON WESTERN EDGE OF GRAND BAHAMA
BANK, BAHAMA ISLANDS, AND THEN NORTH ALONG THE BANK,
RENDEZVOUSING WITH A 23 FOOT TWIN ENGINE BOAT AT A LOCATION
BETWEEN CAT CAY AND ORANGE KEY ON MARCH 18. ALISAN TOOK
THE 23 FOOT BOAT IN TOW WITH INTENTION OF PROCEEDING TO
THREE SEPARATE UNIDENTIFIED LOCATIONS IN BAHAMAS WHERE
ARMS ARE HIDDEN. BAD WEATHER FORCED DELAY BECAUSE OF
CLOSE PROXIMITY OF ROCKS TO THE NECESSARY PASSAGE WHICH
ALVAREZ DESCRIBED ONLY AS BETWEEN CAT CAY AND "THE LIGHT."
WEATHER SUBSIDED SUFFICIENTLY SO THAT ON MARCH 24 AND 25
ARMS WERE COLLECTED FROM SOME UNIDENTIFIED ISLAND. THE
ATTACK AGAINST CUBA WAS MADE ABOUT 1:00 AM MARCH 26,
USING THE 23 FOOT BOAT IN WHICH SEVEN MEN PARTICIPATED.
