On May 11, 1965, a meeting of the Minutemen was scheduled to be held at the DAV Hall, Bogalusa, Louisiana. Only four members showed up and so no formal meeting was conducted. The members who were in attendance were BILL CREEL, ARVIS WARNER, BUDDY JENKINS, and PAUL COONE. // The meeting consisted of an informal discussion among the members who indicated that it had been several weeks since any acts of harassment had been conducted against either BASCOM TALLEY or LOU MAJORS. The members indicated that in the future they should again start these acts of harassment //

ARVIS WARNER claimed that an individual by the name of CARL CHESTANT had paid an initiation fee during the past week and had been sworn into the Catholic Klan. CHESTANT is employed at Odens Shell Service Station which is located on the North end of the Bogalusa Creek Bridge on Columbia Street. After the informal discussion the members then went to the Acme Cafe for refreshments and then disbursed.
