On 9/23/64, JAMES W. HAMBLIN, Racial Informant - Probationary, Vero Beach, Fla., advised he had no knowledge of any organization in this area entitled "MINUTEMEN".

On 9/25/64, HOWARD O. MASTERS, Racial Informant - Probationary, Ft. Pierce, Fla., advised he had no knowledge of the "MINUTEMEN" Organization having a unit in the Ft. Pierce or Stuart, Fla. area.

On 9/28/64, Mrs. BARBARA CLIFTON, Clerk, Credit Bureau of Stuart, Fla., advised that the files of that office reveal a mortgage deed dated 1/28/64, in the name of FRANCIS A. ADAMS. The file reflected Mr. ADAMS maintained a low 4 figure bank account at the Bank of Stuart. Mrs. CLIFTON stated the file contained no further info re FRANCIS A. ADAMS.
