 ADVISED HE RECEIVED A PERSON TO PERSON CALL FROM SUBJECT ON  
 THIS DATE FROM A PHONE BOOTH AND THAT HE HEARD THE OPERATOR NAME  
 THE CHARGE AS \$2.05. [REDACTED] DOES NOT KNOW PLACE FROM WHICH CALL  
 MADE. EL PASO SOURCES ADVISE NO RECORD OF INSTANT TELEPHONE CALL  
 FROM EL PASO OPERATORS BUT SUGGESTS EL PASO COULD BE DIALED  
 DIRECTLY FROM TOWN WHERE CALL MADE WITH NO LOCAL RECORD. ONLY  
 TOWNS IN EL PASO VICINITY WITH PHONE TOLL OF EXACTLY \$2.05 FOR  
 THIS TYPE OF CALL ARE PLAINVIEW, BIG SPRING, AND HEREFORD, ALL  
 TEXAS. [REDACTED] ADVISED POPE REQUESTED HE ASSIST PIMPS FOR QUOTE  
 CHRIS UNQUOTE (LNU) AND QUOTE LOUISE UNQUOTE (LNU) IN MAKING  
 CONTACTS IN EL PASO AREA. [REDACTED] STATED HE REFUSED REQUEST. CHRIS  
 POSSIBLY IDENTICAL WITH CHRIS NOLAN NAMED AS POPE'S ASSOCIATE IN  
 REPORT OF SA ROBERT M. BARRETT AT DALLAS ON AUGUST 8 LAST. ABOVE  
 INFORMATION TELEPHONICALLY FURNISHED DALLAS. INVESTIGATION EL  
 PASO CONTINUING. DALLAS AND LOS ANGELES ADVISED AIRMAIL. POPE  
 IS HEAVILY ARMED AND SHOULD BE CONSIDERED EXTREMELY DANGEROUS.  
 FRYE ALLEGED TO BE IN POSSESSION OF 32 CALIBER AUTOMATIC PISTOL  
 HAS ASSAULTED POLICE OFFICERS IN THE PAST AND SHOULD BE CONSIDERED  
 ARMED AND EXTREMELY DANGEROUS.
