With regard to the lead in rerep to be alert for large deposits in the FPCC bank account, it is to be noted that the financial information made available by NY 3245-S* on 4/21/63 (C) disclosed no unusually large deposits in the FPCC bank account in the period 1/16/63 through 4/12/63. In this period, there were only three deposits in amounts between \$200 and \$300, and it is known through sources that LEE was fairly successful in his appeal for funds. Therefore, there seems to be no indication that LEE received any money in any sizeable amount from the Cuban Government during this period. As a matter of fact, there is an indication in the letter of ENRIQUE FINLAY, set forth herein, that the Cuban Government has a rather low regard for LEE as Director of the FPCC.
