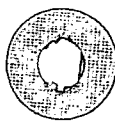

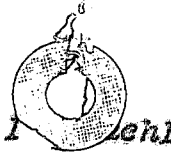

Subject is former acting Executive Secretary of Fair
Play for Cuba Committee. He is on Security Index. When
interviewed 8-16-62, subject indicated he would assist FBI
and/or CIA as particular informant. He frankly admitted such
service was not motivated by allegiance to U. S. and further
advised he did not particularly like FBI. [S]

Memo Wannall to Sullivan 10-25-62 recommended and
approved no attempt be made to develop Gibson as informant.
CIA was advised of subject's willingness to cooperate and CIA
advised consideration would be given to utilize Gibson on an
intelligence mission inside Cuba. [S]
