Re: Airtel 4-1-64 setting forth allegation of Theodore Lee received from NY 3948-Q. Allegation set forth in airtel is similar to allegation made by Mark Lane who is known to your office in testimony before the President's Commission alleging that a week prior to the assassination of President Kennedy a meeting took place at the Carousel Club in Dallas, Texas, which was attended by Mr. Bernard Weissman, Dallas Police Officer J. D. Tippitt, and Jack Ruby. Investigation has developed no information indicating that such a meeting ever took place or that such a meeting was ever likely.

In view of the nature and Commission's interest in above allegation, additional efforts should be made to reinterview Lee specifically concerning statements set forth in airtel. While protection of your informant should be borne in mind, if cooperative Lee should be pinned down to specifics. If uncooperative, we should at least give him opportunity to put up or shut up in view of his past position and influence as head of Fair Play for Cuba Committee (FPCC).

Incorporate pertinent information set forth in airtel as well as results of attempt to interview Lee concerning this matter in letterhead memorandum form suitable for dissemination to the President's Commission.
