Misur survey at ~~Town and Country Motel~~, 1850
State Road, Cuyahoga Falls, Ohio, conducted on 5/27/65.
Installation at this location with monitoring at Cleveland
Office, central plant, not possible at this time. It was
determined that Mrs. MILANO, due to a temporary illness,
has limited her activity and spends majority of time at
motel. Periods away from motel room are for short periods
only.

Mrs. MILANO has indicated to motel operator that
she expects her son and her husband to be in Cuyahoga Falls,
prior to wedding, July 10, 1965, and has inquired re
accommodations for them at motel although no definite
arrangements made. Mrs. MILANO has indicated that she
is considering moving to kitchenette apartment in same motel
when other members of family arrive. Because of her
possible move to another room and her limited periods away
from the room, no permanent installation will be made,
however, UACB, a WASP will be installed in Room 119 and
will be monitored on a select basis from a local plant.
In the event she does move, a survey of the new quarters
will be made prior to occupancy and misur coverage
installed, consistent with full security.
