This letter and enclosed LHM are classified "Secret" to protect sensitive source and the sensitive nature of the investigation into the activities of diplomatic personnel. (S) (U)

Enclosed for FBI HQ are 6 copies of an LHM for transmittal to Legat, Rome.

The first confidential source mentioned in the LHM is NY [2340-S] (S) (U)

The identities of the other government agency, the confidential source abroad, and the second confidential source are located on the Non-Symbol Source Page attached.

For the information of FBI HQ and Legat, Rome, the telephone call on 8/11/74, although charged to the home telephone of ALADDIN AL-TAYYAR, #879-8023, was placed from #454-292. This telephone is listed to HAYGAN MAYCOCK, 101-10 Farmers Boulevard, Hollis, New York. Indices of the NYC negative re MAYCOCK. (S) REC 53 [105-263921-49] (S)

In addition to telephone calls made to Lebanon, there were additional overseas telephone calls placed from AL-TAYYAR's home phone during the period July through December, 1974. Toll records indicate that on 9/28 and 10/6/74, calls were placed to WILLIAM APIKIAN in France; on 10/13/74, a call was placed to the Iraq Ambassador in Paris, France; and on 11/5/74, a call was placed to NATIK SHAKIR, Parliament Boulevard, Baghdad, Iraq.
