Re New York letter and LHM dated 1/11/67.

On 2/7/67, ^(S) ~~MM~~ [1140] identified a photograph of RALPH SERRANO, subject of Miami file 62-4447, as that of an individual known to him as "RALPH" who visited EUGENE MAXIMILIEN, Haitian Consul in Miami, several times in the latter part of 1966. "RALPH" acted and talked "like a hoodlum", and, in the informant's opinion, had a criminal background. He was also a friend of MITCHELL WER BELL who was also in touch with MAXIMILIEN during this period.

An FD-9 has been submitted to the Bureau regarding RALPH SERRANO, under FBI number 1 013 752. The last entry on subject's criminal record returned from the FBI Identification Division reflects that he was fingerprinted on 10/15/64 by U. S. INS, New York, N.Y., under the name RALPH LAURO SERRANO, A number 3 386 567 NYC. Charge was deportation proceedings, and disposition deported from New York City for Santo Domingo via Pan American Airlines Flight 231 on 1/9/65.
