On December 4, 1969, a confidential informant, who has furnished reliable information in the past, advised that he had been given the following information by Lieutenant Colonel Uri Yarom, Assistant Armed Forces Attache, Embassy of Israel, Washington, D. C.:

On December 4, 1969, a Mr. Mitchell Warbell (phonetic) from Atlanta, Georgia, Wanted Yarom to come to S a local hotel (not named) in Washington to meet him, Warbell. (Yaromm) said that he asked Warbell if some "story" (5) is really serious or if "they" are going to make it so. Yarom was told by Warbell that the "story" was not true. Yarom mentioned that he was bothered by the fracial thing [ ] and was told by Warbell that this was not true either. [Yarom] was told by Warbell that he, Warbell, wanted to talk about "some equipment" that is "over there"

On December 5, 1969, the informant again advised that [Yatom had mentioned that he would meet Warbell at an 65] unknown place for breakfast at which time Warbell would bring an American friend who wanted to discuss a few things with Yarom. Warbell told Yarom that he wanted to talk about (S\_ some "devices" he sent "over there" about two years ago, but Yarom told the informant he did not recall the devices mentioned by Warbell
