This is to advise that I discussed this matter with D1 119 C (RAC) on 1/22/64. Informant<sup>(1)</sup> advised that the organization associated with the Association of ARKANSAS KLANS OF THE KU KLUX KLAN is not affiliated with any other organization except the KLAN In Arkansas even though it is known by the name of "Minutemen". In 1959, there was an effort to affiliate with the State Police in Arkansas as unofficial officers to assist in any race situation. In event of an emergency, the Klan members were to be called in as auxiliary police to assist local and State Police in organization. The emergency never materialized and the effort became dormant. Informant<sup>(2)</sup> stated that this group had no affiliation or association with any other organization of the same name and informant had never heard of the organization in Missouri.
