ADMINISTRATIVE

Instant report is classified secret in view of the information contained (in CIA letter to Director January 11, 1961, which was classified secret, and also information contained in Washington Field Office communication dated August 8, 1961, attributable to CIA was cause for the communication being classified secret,] and in the event of downgrading, instant communication should always remain classified confidential, as it contains information from Department of State aerogram dated April 19, 1961, which was classified confidential. (u)

Period in instant report is extensive as it includes investigative periods of auxiliary offices.

A separate file (31-7514) has been opened in the Miami Office on the basis of information furnished concerning the subject and his reported activities in connection with prostitution. Information was furnished to SA WILLIAM B. HOLLOMAN on September 15, 1961, by ANGELINA H'LETIURCHERS Y MORILLO, PCI of the Miami Office.
