Miami notified CIA locally of pertinent developments from the outset.

Mr. AHRENS, District Director, INS, confided that the ten prisoners were being transported via Border Patrol plane to Washington, D. C., and that Mr. LOU GIDEL, in charge of Travel Control, INS, Miami, accompanied the group.

Mr. AHRENS said that more detailed information concerning their schedule and plans could be obtained from the Central Office of INS, Washington, D. C.
